ጠቅላላ ድንጋጌዎች

1. አጭር ርዕስ

ይህ አዋጅ "የኦሮሚያ ክልል የወረዳ፣ የገጠር ቀበሌ፣ የከተማ አስተዳደር፣ የከተማ ወረዳ እና የከተማ ቀበሌ ምክር ቤቶች አባላት ምርጫ አዋጅ ቁጥር 259/2016" ተብሎ ሊጠቀስ ይችላል።

WHEREAS, it has become essential to conduct election of the Woreda and Kebele Council Members in accordance with amended Constitution of Oromia Regional State, Proclamation Number 46/2001, as well as to hold election of the City Administration, City Woreda and City Kebele Council Members in accordance with Oromia Region Urban Proclamation Number 250/2023;

WHEREAS, the power of enacting laws for election of the Woreda, Rural Kebele, City Administration, City Woreda and City Kebele Council Members has been vested in the Regional States under Article 8 (2 and 4) of the Ethiopian Electoral, Political Parties Registration and Election's Code of Conduct Proclamation Number 1162/2019, hence it has become essential to enact proclamation used for the election of these Council Members;

NOW, THEREFORE, in accordance with Article 49 (3) (a) of Oromia Regional State's Amended Constitution, Proclamation Number 46/2001, this Proclamation is hereby Proclaimed.

Part One

General Provisions

1. Short Titles

This Proclamation may be cited as "Election Proclamation of the Woreda, Rural Kebele, City Administration, City Woreda and City Kebele Council Members of Oromia Region, Number 259/2024."

2. Hiika

Akkaataan jechichaa hiika biroo kan kennisiisuuf yoo ta’e malee, Labsii kana keessatti:

- 1) “Aanaa” jechuun akkaataa Heera Mootummaa Naannichaatiin gurmaa’insa qaamolee Mana Maree Aanaa, Mana Maree Bulchiinsaafi qaama abbaa seerummaa qabaachuun hundaa’edha.
- 2) “Aanaa Magaalaa” jechuun gurmaa’insa magaalaa sadarkaa magaalota Meetroopoolisiifi Riijiyoo poolis keessatti Kutaa Magaalatti aanee qaama gurmaa’u ta’ee, Mana Maree, Mana Maree Bulchiinsaafi Mana Murtii Hawaasummaa qabaachuun kan hundeeffameefi sadarkaa magaalota kanaatti caasaa bulchiinsaa magaalaa isa jalqabaati.
- 3) “Caffee” jechuun Caffee Oromiyaa bu’uura Heera Naannichaa Fooyya’ee Bahe, Labsii Lakkoofsa 46/1994 Keewwata 46 (1) tiin hundeeffameedha.
- 4) “Ganda Baadiyyaa” jechuun gurmaa’insa Aanaa keessatti Bulchiinsa Aanaatti aanee kan gurmaa’u ta’ee, Mana Maree, Mana Maree Bulchiinsaafi Mana Murtii Hawaasummaa Gandaa qabaachuun kan hundeeffameefi gurmaa’ina bulchiinsaa isa jalqabaati.
- 5) “Ganda Magaalaa” jechuun gurmaa’insa magaalaa sadarkaa Magaalota Muummee keessatti Kutaa Magaalatti aanee yookiin Magaalota O’anaafi isaa gadi jiran keessatti Bulchiinsa Magaalatti aanee kan gurmaa’u ta’ee, Mana Maree, Mana Maree Bulchiinsaafi Mana Murtii Hawaasummaa Gandaa qabaachuun kan hundeeffameefi caasaa bulchiinsaa Magaalaa isa jalqabaati.

2. ትርጉሚ

- 1) “ወረዳ” ማለት በክልሉ መንግሥት ሕገ-መንግስት መሠረት የወረዳ ምክር ቤት፣ አስተዳደራዊ ምክር ቤት እና የዳኝነት ሥልጣን አካላት አደረጃጀት ያለው ሆኖ የተቋቋመ ነው።
- 2) “የከተማ ወረዳ” ማለት በሜትሮፖሊስ እና በሪጂዮፖሊስ ከተሞች ደረጃ የከተማ አደረጃጀት ውስጥ ከክፍለ-ከተማ ቀጥሎ የሚደራጅ አካል ሆኖ፣ ምክር ቤት፣ አስተዳደራዊ ምክር ቤት እና ማህበራዊ ፍርድ ቤት ኖሮት የተቋቋመ እና በዝሊህ ከተሞች ደረጃ የመጀመሪያው የከተማ አስተዳደር መዋቅር ነው።
- 3) “ጨፌ” ማለት ተሻሽሎ በወጣው የክልሉ ሕገ-መንግሥት፣ አዋጅ ቁጥር 46/1994 አንቀጽ 46 (1) መሠረት የተቋቋመ የኦሮሚያ ጨፌ ነው።
- 4) “የገጠር ቀበሌ” ማለት በወረዳ አደረጃጀት ውስጥ ከወረዳ አስተዳደር ቀጥሎ የሚደራጅ ሆኖ፣ ምክር ቤት፣ አስተዳደራዊ ምክር ቤት እና የቀበሌ ማህበራዊ ፍርድ ቤት ኖሮት የተቋቋመ እና የመጀመሪያው የአስተዳደር አደረጃጀት ነው።
- 5) “የከተማ ቀበሌ” ማለት በዋና ከተሞች ደረጃ የከተማ አደረጃጀት ውስጥ ከክፍለ-ከተማ ቀጥሎ ወይም በክፍተኛና ከዚያ በታች በሆኑ ከተሞች ውስጥ ከከተማ አስተዳደር ቀጥሎ የሚደራጅ ሆኖ፣ ምክር ቤት፣ አስተዳደራዊ ምክር ቤት እና የቀበሌ ማህበራዊ ፍርድ ቤት ኖሮት የተቋቋመ እና የመጀመሪያው የከተማ አስተዳደር መዋቅር ነው።

2. Definition

Unless the context requires otherwise, in this Proclamation:

- 1) “Woreda” means a structure established pursuant to the constitution of the Region as having Woreda Council, Administrative Council and the judiciary.
- 2) “City Woreda” means structure of the City organized next to the Sub City in Metropolis and Regiopolis City levels; and is established having a Council, Administrative Council and Social Court and is the first or beginning structure of the City Administration at these Cities’ level.
- 3) “Caffee” means the Caffee Oromia established pursuant to Article 46 (1) of the Amended Constitution of the Regional State, Proclamation Number 46/2002.
- 4) “Rural Kebele” means a structure organized next to the Woreda Administration in the Woreda organization structure which is established as having the Council, Administrative Council and the kebele Social Court and is the initial administrative structure.
- 5) “City Kebele” means an organization (structure) of a City organized next to the Sub City in the principal Cities level or organized next to the City Administration in the Higher and below level Cities; and established by having Council, Administrative Council and the Kebele Social Court and is the initial or beginning Administrative structure of the City.

- 6) “Bulchiinsa Magaalaa” jechuun magaalaa qaamni seerummaa kennameef ta’ee, Mana Maree mataa isaa, Mana Maree Bulchiinsaafi qaama aangoo abbaa seerummaa kan qabu ta’ee, Magaalota sadarkaa Meetroopolis, Riijiyooopolis, Muummee, Ol’aanaa, Giddugaleessaafi Guddattuutti hundeeffameedha.
- 7) “Mana Maree” jechuun qaama abbaa aangoo ol’aanaafi bakka bu’aa ummataa ta’ee, sadarkaa Aanaa, Ganda Baadiyyaa, Bulchiinsa Magaalaa, Aanaa Magaalaafi Ganda Magaalaatti filannoo ummataatiin hundeeffameedha.
- 8) “Mootummaa” jechuun Mootummaa Naannoo Oromiyaati.
- 9) “Naannoo” jechuun Naannoo Oromiyaati.

3. Daangaa Raawwathiinsaa
 Labsiin kun Naannicha keessatti filannoo miseensota Manneen Maree Aanaa, Ganda Baadiyyaa, Bulchiinsa Magaalaa, Aanaa Magaalaafi Ganda Magaalaa gaggeeffamu hunda irratti raawwathiinsa ni qabaata.

4. Ibsa Koornayaa
 Labsii kana keessatti jechi koornayaa dhiiraatiin ibsame kan dubartiis ni dabalata.

5. Sirnaafi Qajeeltoowwan Bu’uuraa Filannoo

1) Filannoon sadarkaa Aanaa, Ganda Baadiyyaa, Bulchiinsa Magaalaa, Aanaa Magaalaafi Ganda Magaalaatti gaggeeffamu kaadhimamtoota dorgoman keessaa akkaataa duraa duuba isaaniitiin kaadhimamtoonni sagalee caalmaa argatan moo’ataa ta’u.

- 6) “የከተማ አስተዳደር” ማለት የሕግ ሰውነት የተሰጠው ከተማ ሆኖ፣ የራሱ ምክር ቤት፣ አስተዳደራዊ ምክር ቤት እና የዳኝነት ሥልጣን አካል ያለው ሆኖ፣ በሚትሮፖሊስ፣ በሪጂዮፖሊስ፣ በዋና፣ በከፍተኛ፣ በመካከለኛና በአዳጊ ከተሞች ደረጃ የተቋቋመ ነው።
- 7) “ምክር ቤት” ማለት ከፍተኛው የሥልጣን ባለቤት የሆነ አካል እና የሕዝብ ተወካይ ሆኖ፣ በወረዳ፣ በገጠር ቀበሌ፣ በከተማ አስተዳደር፣ በከተማ ወረዳ እና በከተማ ቀበሌ ደረጃ በሕዝብ ምርጫ የተቋቋመ ነው።
- 8) “መንግሥት” ማለት የአሮሚያ ብሄራዊ ክልላዊ መንግሥት ነው።
- 9) “ክልል” ማለት የአሮሚያ ክልል ነው።

3. የአፈጻጸም ወሰን
 ይህ አዋጅ በክልሉ ውስጥ በሚካሄድ የወረዳ፣ የገጠር ቀበሌ፣ የከተማ አስተዳደር፣ የከተማ ወረዳ እና የከተማ ቀበሌ ምክር ቤቶች አባላት ምርጫ በሙሉ ላይ ተፈጻሚነት ይኖረዋል።

4. የጾታ አገላለጽ
 በዚህ አዋጅ ውስጥ በወንድ ጾታ የተገለጸው ቃል የሴትንም ይጨምራል።

ክፍል ሁለት
የምርጫ ሥርዓት፣ መሠረታዊ መርሆዎች እና የምርጫ አስፈጻሚ አካል

5. የምርጫ ሥርዓት እና መሠረታዊ መርሆዎች

1) በወረዳ፣ በገጠር ቀበሌ፣ በከተማ አስተዳደር፣ በከተማ ወረዳ እና በከተማ ቀበሌ ደረጃ የሚካሄድ ምርጫ ከተወዳደሩት ዕጩዎች መካከል አብላጫ ድምጽ ያገኙት ዕጩዎች እንደ ቅደም ተከተላቸው አሸናፊ ይሆናሉ።

- 6) “City Administration” means a City which is given with legal personality having its own Council, Administrative Council and the judiciary established in the Metropolis, Rejiopolis, Principal, Higher, Medium and Emerging City levels.
- 7) “Council” means a body established as the representative of the people with the supreme (highest) power at the Woreda, Rural Kebele, City Administration, City Woreda and City Kebele by the public vote.
- 8) “State” means Oromia National Regional State.
- 9) “Region” means Oromia Region.

3. Scope of Application
 This Proclamation shall be applicable to all elections of Council Members of the Woreda, Rural Kebele, City Administration, City Woreda and City Kebele conducted in the Region.

4. Gender Reference
 In this Proclamation, any term expressed in masculine gender shall include the feminine.

Part Two

Electoral Systems, Principles and Election Implementation Body

5. Systems and Basic Principles of Election

1) Among the candidates who competed in the election conducted at the Woreda, Rural Kebele, City Administration, City Woreda and City Kebele levels, the candidates who won the highest vote shall become the winners in their consecutive order.

- 2) Filannoon miseensota Manneen Maree sadarkan jiran haala hirmaannaa ummataa mirkaneessen karaa bilisa, kallattiifi akkaataa kenna sagalee iccitiitiin kan filataman ta'a.
- 3) Lammiin mirga filachuufi filatamuun isaa seeraan yookiin murtii Mana Murtiitiin hin daangeeffamne fedhii isaatiin filachuu yookiin filatamuu ni danda'a.
- 4) Sagaleen tokkoon tokkoo filataan kennu walqixadha.
- 5) Filataan kamiyyuu sagalee kennuuf bakka filannoon gaggeeffamutti qaamaan argamee filachuu qaba.
- 6) Namni filannoo Mana Maree kamiifuu dorgomuuf dhiyaatu seera filannoo biyyaalessaatiin ulaagaa ibsame kan guutuufi Afaan Oromoo kan danda'u ta'uu qaba.

6. Qaama Filannoo Raawwachiisu

- 1) Boordiin Filannoo Biyyaalessaa Itoophiyaa bu'uura Labsii kanaafi seeroota roqummaa qabaniin filannoo kana kan raawwachiisu ta'a.
- 2) Qaamni Mootummaa Naannichaa yookiin namni kamiyyuu Boordii Filannoo Biyyaalessaa Itoophiyaatiin yookiin hojjetoota isaatiin deeggarsa yammuu gaafatamu deeggarsa barbaachisaa taasisuuf dirqama qaba.

7. Filannoo Miseensota Mana Maree Aanaa

- 1) Filannoon miseensota Mana Maree Aanaa kan gaggeeffamu Gandoota Aanicha keessatti argaman bu'ureffachuun ta'a.
- 2) Miseensonni Mana Maree Aanaa, jiraattota Gandoota Aanicha keessatti argaman gidduudhaa kallattiidhaan ummataa kan filataman ta'a.

2) በየደረጃው ያሉ ምክር ቤቶች አባላት ምርጫ የሕዝብ ተሳትፎን ባረጋገጠ ሁኔታ፣ ነጻና ቀጥተኛ በሆነ መንገድ በሚስጥራዊ የድምጽ አሰጣጥ ዘዴ የሚመረጡ ይሆናል።

3) የመምረጥ እና የመመረጥ መብቱ በሕግ ወይም በፍርድ ቤት ውሳኔ ያልተገደበበት ዜጋ በፍላጎቱ ሊመርጥ ወይም ሊመረጥ ይችላል።

4) መራጭ የሚሰጠው አያንዳንዱ ድምጽ አኩል ነው።

5) ማንኛውም መራጭ ድምጽ ለመስጠት ምርጫው በሚካሄድበት ቦታ በአካል ተገኝቶ መምረጥ አለበት።

6) ለየትኛውም ምክር ቤት ምርጫ ለመወዳደር የሚቀርብ ሰው በብሔራዊ ምርጫ ሕግ የተገለጸውን መስፈርት የሚያሟላ እና "Afaan Oromoo" በአግባቡ የሚችል መሆን አለበት።

6. የምርጫ አስፈጻሚ አካል

1) የኢትዮጵያ ብሔራዊ ምርጫ ቦርድ በዚህ አዋጅና አግባብነት ባላቸው ሕጎች መሠረት ምርጫ የሚያስፈጽም ይሆናል።

2) የክልሉ መንግሥት አካል ወይም ማንኛውም ሰው በኢትዮጵያ ብሔራዊ ምርጫ ቦርድ ወይም በርሱ ሰራተኞች ድጋፍ በሚጠየቅበት ጊዜ አስፈላጊውን ድጋፍ የማድረግ ግዴታ አለበት።

ክፍል ሦስት

ስለ ምርጫ እና የምክር ቤቶች አባላት ለውጥ

7. የወረዳ ምክር ቤት አባላት ምርጫ

1) የወረዳ ምክር ቤት አባላት ምርጫ የሚካሄደው በወረዳው ውስጥ የሚገኙትን ቀበሌዎች መሠረት በማድረግ ይሆናል።

2) የወረዳ ምክር ቤት አባላት በወረዳው ውስጥ ከሚገኙት ቀበሌዎች መካከል በቀጥታ በሕዝብ የሚመረጡ ይሆናል።

2) The Council Members of each level shall be elected in a manner that ensures the people's participation, freely, directly and in a secret ballot voting.

3) A citizen whose rights to elect and to be elected is not suspended (limited) by law or decision of court may elect or be elected in his own interest.

4) Each vote casted by each voter shall be equal.

5) Every voter shall cast his vote by appearing at the polling station in person.

6) Any person who competes for a Council of any level shall meet the criteria specified by the National Electoral Law and shall know Afaan Oromoo.

6. Election Administration Body

1) The National Electoral Board of Ethiopia shall administer (implement) this election pursuant to this Proclamation and other pertinent laws.

2) Every government organ of the Region or any person is obliged to cooperate up on request by the National Electoral Board of Ethiopia or its employees.

Part Three

Election and Change of the Council Members

7. Election of the Woreda Council Members

1) Election of the Woreda Council Members shall be conducted based on the Kebeles found within the Woreda.

2) The Woreda Council Members shall be elected amongst the residents of the Kebeles found in the Woreda directly by the people.

- 3) Baay'ina miseensaa Mana Maree Aanaa, Ganda tokko irraa filatamu 3 ta'a.
- 4) Keewwata Kana Keewwata Xiqqaa 3 jalatti kan tumame jiraatus, Aanaa Gandoota baadiyyaa 10 (kudhanii) gadi qabu keessatti baay'inni miseensoota Mana Maree Aanaa Ganda tokko irraa filataman 5 hanga 7 ta'uu ni danda'a.

8. Filannoo Miseensota Mana Maree Ganda Baadiyyaa

- 1) Filannoon miseensota Mana Maree Ganda Baadiyyaa kan gaggeeffamu jiraattoota Gandicha keessatti argaman bu'uurreeffachuun ta'a.
- 2) Miseensonni Mana Maree Ganda Baadiyyaa jiraattoota Gandichaatiin kallattiin kan filataman ta'a.

- 4) Notwithstanding to the provision under Sub Article 3 of this Article, the number of Woreda Council members elected from one Kebele in the Woreda having less than 10 (Ten) Rural Kebeles may be from 5 to 7.

8. Election of Rural Kebele Council Members

- 1) Election of the Council Members of Rural Kebele shall be conducted based on the residents found in the Kebele.
- 2) Members of the Rural Kebele Council shall be elected directly by the residents of the Kebele.
- 3) One member of the Rural Kebele Council shall represent a minimum of 5 residents and maximum of 200 residents of the Kebele.
- 4) The number of the Council members of one Rural Kebele shall be from 100 to 300.
- 5) Notwithstanding to the provision under Sub Article 4 of this Article, in the Kebeles having small number of population and in the Kebeles having large number of population, the number of Council Members may be less than 100 or more than 300 respectively.
- 6) Where the number of Oromo nationality among the residents is found to be less in a Rural Kebele, Caffee Oromia may, by considering this number vis-à-vis the number of other people,decide that 51%seats to be reserved for it in the Rural Kebele Council.

- 2) Election of the Council Members of the Metropolis, Rejiopolis, Principal, Higher, Medium and Developing Cities shall be elected directly by the residents of each city.
- 3) The Council member of one City shall represent from 300 to 4000 residents of the City.
- 4) Without prejudice to the provision under Sub Article 3 of this Article, the number of members of the City Council in the Cities shall be as follows:
 - (a) Metropolis City -----250 to 360;
 - (b) Rejiopolis City -----200 to 250;
 - (c) Principal City -----100 to 180;
 - (d) Higher City -----80 to 120;
 - (e) Medium City -----60 to 90;
 - (f) Emerging City -----50 to 70.
- 5) If the number of residents who are Oromo nationality is found to be less in these Cities, Caffee Oromia may, by considering the number of Oromo people vis-à-vis the number of other people, decide that 51%seats to be reserved for it in the City Council.
- 6) The election to be conducted in these Cities, regarding the number of Oromo People and residents of the rural kebeles surrounding the City shall be performed as follows:

- (a) Gandi yookiin Gandoota baadiyyaa magaalota kana daangeesaniif teessoo Mana Maree magaalota kanaa keessaa % 20 ni eegamaaf;

10. Election of the City Woreda Council Members

- 1) Election of the City Woreda Council Members shall be held based on residents of the City Woreda.
- 2) The City Woreda Council Members shall be elected directly by the residents of the City Woreda.
- 3) One member of the City Woreda Council shall represent from 150 to 400 residents of the City Woreda.
- 4) The number of members of the City Woreda Council shall be from 150 to 250 depending on the number of their residents.
- 5) If the number of residents of Oromo nationality is found to be less in the City Woreda, the Caffee Oromia may, by considering the number of Oromo people vis-à-vis the number of other people, decide that 51% seats shall be reserved for it in the City Woreda Council.

11. Election of the City Kebele Council Members

- 1) Election of the City Kebele Council Members shall be conducted based on the residents of the City Kebele.
- 2) The City Kebele Council Members shall be elected directly by the residents of the City Kebele.

- 3) Miseensi Mana Maree Ganda Magaalaa tokko jiraattoota Ganda Magaalichaa 30 hanga 100 bakka bu'a.
- 4) Baay'inni miseensoota Mana Maree Ganda Magaalaa akkaataa baay'ina jiraattoota qabaniin 100 hanga 300 ta'a.

13. የሁሉም ደረጃ ምክር ቤቶች አባላት ብዛት ለውጥ

በዚህ አዋጅ አንቀጽ 7፣ 8፣ 9፣ 10 እና 11 ሥር የተደነገገው ቢኖርም፣ የማንኛውም ደረጃ ምክር ቤቶች አባላት ብዛትን መቀየር አስፈላጊ ሆኖ ከተገኘ፣ የክልሉ መንግሥት አስተዳደራዊ ምክር ቤት ደንብ በማውጣት ወስኖ ምርጫ መካሄድ ካለበት ቀን 6 (ስድስት) ወር አስቀድሞ ለኢትዮጵያ ብሔራዊ ምርጫ ቦርድ ማሳወቅ ይችላል።

- 3) One member of the City Kebele Council shall represent from 30 to 100 residents of the City Kebele.
- 4) The number of members of the City Kebele Council shall be from 100 to 300 depending on the number of their residents.
- 5) If the number of residents of Oromo nationality is found to be less in the City Kebele, the Caffee Oromia may, by considering this number vis-à-vis the number of other people decides that 51% Seats to be reserved for it in the City Kebele Council.

12. Election of Council Members of Municipality and Developing Municipality City

- 1) Without the need to specifically establish an independent City Council for the Municipality and Developing Municipality City, they shall have their involvement in the Woreda Council being considered as a Kebele or Kebeles.
- 2) Where a City is promoted (developed) from Municipality City and Developing Municipality City level to the City having a Council, if there exist an issue requiring the decision of the Council until the next election, it shall be decided by the Council of the Woreda under which they have been governed.

13. Alteration of the Number of Council Members of All Levels

Notwithstanding to the provisions under Articles 7, 8, 9, 10 and 11 of this Proclamation, if it deemed essential to change the number of Council Members at any level, the Regional State Administrative Council may, by deciding in its Regulation, notify same to the National Electoral Board of Ethiopia 6 (six) months prior to the date of the election.

- 1) አንድ ከተማ ቀድሞ ከነበረበት ደረጃ ወደ ከፍተኛ ደረጃ ከተማነት ካደገ የሚቀጥለው ምርጫ እስከሚካሄድ ድረስ የከተማው የምክር ቤት አባላት ብዛት ባለበት የሚቀጥል ይሆናል።

14. Establishment of New Administrative Structure

If a new Woreda, Rural Kebele, City Administration, City Woreda and City Kebele is organized by the decision of Government, the Council Members that have been previously elected and represented the people at that level shall continue their function until the next election be conducted in accordance with the new organization or structuring.

15. Upgrading of Cities

- 1) If a City/Town is upgraded from its previous grade to the next higher grade/level, the number of Council Members of such City/Town shall continue as it is until the next election.
- 2) Notwithstanding to the provision under Sub Article 1 of this Article, the number of Council Members shall be increased at the next election depending on the number of people.

**Part Four
Miscellaneous Provisions**

16. Duty to Cooperate
Every person has obligation to cooperate or provide his support in order to implement this Proclamation.

17. Power to Issue Regulation
The Regional State's Administrative Council may issue Regulation so as to implement this Proclamation.
